3. Electric hookup is limited to the number of connections and total load identified on the front of this application. The reliability of electrical service provided to the vendor is not guaranteed and failure of service for any period of time does not constitute a breach of agreement and no refund of rent will be made in such cases. Electric for storage/box trucks is not guaranteed to be available within your vending space.
4. Food vendors must maintain strict compliance with all food related state and county health codes and must provide a copy of their vendor license.
5. The Muskie Days committee will assign vendor locations based on space availability, the footprint of your operation, and proximity to electrical needs.
6. The Nevis C&C reserves the right to cancel this event at any time. If the event is canceled, refunds will be issued. No refunds will be given due to weather.
